GENE MIGLIACCIO, Dr.P.H.



Gene Migliaccio was appointed Director, Federal Occupational Health Service (FOH), Office of the Assistant Secretary for Administration, U.S. Department of Health and Human Services, Washington, D.C. on January 21, 2007.

As Director of FOH, Dr. Migliaccio provides leadership to the nation's largest Federal provider of occupational health services. FOH serves more than 360 Federal agencies and reaches 1.8 million Federal employees, providing Clinical, Wellness/Fitness, Employee Assistance Program (EAP), Work/Life, and Environmental Health and Safety services. Dr. Migliaccio oversees an organization that includes 304 clinics, 42 fitness centers, 76 counseling offices, and a national network of over 30,000 occupational health physicians, mental health counselors and environmental health professionals. He works in partnership nationally and internationally with Federal organizations to design and deliver comprehensive occupational health solutions

A retired United States Public Health Service (PHS) Commissioned Corps Officer, Dr. Migliaccio managed an integrated health care delivery system as the Director of Immigration Health Services within U.S. Immigration and Customs Enforcement (ICE), Department of Homeland Security (DHS). He is the former Chief of Staff (Acting) for the Office of the U.S. Surgeon General. His other assignments have included positions in hospital administration, managed care, information technology, and health care research. He has health care legislative experience at both the federal and state levels, serving as a legislative aide for the U.S. House of Representatives and a legislative researcher for the Hawaii State Legislature, Senate Health Committee.

Dr. Migliaccio holds a Doctor of Public Health (Dr.P.H.) from Tulane University School of Public Health and Tropical Medicine, a Master of Public Health (M.P.H.) from the University of Hawaii School of Public Health, and a Bachelor of Arts from Marquette University. After earning his doctoral degree, he served in the U.S. Air Force Medical Service Corps as health services administrator until joining the PHS Commissioned Corps. In 2007, he was appointed as a member of the federal government's Senior Executive Service.

He is Board Certified in Health Care Management, and a Fellow in the American College of Health Care Executives (ACHE). He also serves as an adjunct professor of global public health at The George Washington University School of Public Health and Health Services.

Dr. Migliaccio is a highly decorated career officer who has received numerous PHS, military, and private sector awards. Additionally, he received recognition for attaining meritorious national distinction in the field of public health by Delta Omega, the public health society. He also received a Proclamation from the Mayor of Houston for assistance with coordinating the federal health care response to over 200,000 Katrina evacuees in Houston, Texas.
